## Landscape & Housinga

- \* Maintain Green Belt around villages
- \* Retain “village” character
- \* Allow limited small scale, sympathetic development for sustainability
- \* Integrate any allowed development into the villages
- \* Ensure design respects local Staffordshire rural style



## Transport

- \* Review speed limits across the Parish
- \* Support appropriate traffic calming measures
- \* Improve safety in the lanes
- \* Improve access at junctions
- \* Improve pedestrian & cycle routes
- \* Improve public transport links



## Community Facilities & Leisure

- \* Ensure community facilities meet the Parish needs
- \* Enable residents, all ages, to participate in multi activities
- \* Improve recreation facilities including a dedicated children's playground
- \* Promote individual and community well-being



## Rural Economy & Infrastructure

- \* Support businesses through small scale expansions
- \* Encourage better infrastructure/services
- \* Encourage activities which attract rural tourism
- \* Support rural diversification with additional businesses/services
- \* Resist inappropriate land use
