There was further discussion re the weeds in the church car park and the need for them to be treated. This was to go on the agenda for full council along with the discussion around the condition of the ground surface.	
66 66.1	Transfer of Land Cllr Meere reported that she was awaiting costings from a local solicitor re the transfer of land at Gentleshaw.	
67 67.1	Flower tubs around the Parish Longdon Green residents have requested flower tubs. It was agreed to speak with Cllr Fullwood to ascertain number of tubs required and local residents who would be willing to look after them. Clerk was then given the authority to buy the tubs and compost. Proposed: Cllr Taylor; Seconded: Cllr Meere It was resolved that clerk would buy the planters and compost on Cllr Fulwood's instruction.	
68 68.1	Update on current projects <u>Flower Tubs</u> There was the need to replace some of the damaged and rotting flower tubs around the parish. Clerk and Cllr Fulwood to address this at the same time as the tubs in item 67.1.	
68.2	<u>Tree Works</u> Two quotes had been received for the agreed tree works in Berkeley Way and in Church Hollow – one for £1,900 and one for £900. Cllr Taylor requested that an additional quote be sought before a decision was made. Cllr Taylor to provide details of third contractor to clerk.

70 70.1	Update on footpaths and bridleways <u>Footpath 72</u> – addressed earlier in the meeting <u>Footpath 33</u> – stile at Hill Top – the footplate is loose and would be replaced on 12 July by Mr Pinson in the agreed programme of work. <u>Footpath 36</u> – Glebe field had been mown and the hay taken away but more cutting back needed to take place in order to make the footpath fully passable. <u>Footpath 46</u> – works to the path to Giddywell will be undertaken on 12 July by Mr Pinson in the agreed programme of work. <u>Footpath 54</u> – this has now been waymarked <u>Footpath 30</u> –repairs have taken place to the top gate at the churchyard on the path to Hill Top. <u>Footpath 73</u> - the path was overgrown by the stream and needed clearing. This would be done on the 12 July by Mr Pinson in the agreed programme of works. <u>Footpath 53/52/54</u> – a new gate was needed on 52 and undergrowth needed cutting back to allow for free movement of walkers.
